

## Sigep 2019 – School group admission regulations

### INTRODUCTION

Sigep is an international venue for high-ranking companies and is open to professional operators only. In view of the numerous complaints about school groups from exhibitors in past shows, Italian Exhibition Group Spa has drawn up a set of simple but stringent regulations to be followed by school groups. The number of students allowed to visit the show is restricted.

### ARTICLES

1. School groups from professional institutes are allowed to visit only if these institutes are accredited, and only to students in the last year of the course, and **only on 22nd and 23rd January 2019.**
2. For accreditation please apply [annamaria.bonfe@iegexpo.it](mailto:annamaria.bonfe@iegexpo.it) by and no later than **15th November 2018** to the following address
3. Consider yourself officially invited only after receiving a written reply accepting visitor candidacy.
4. Once the maximum limit of pre-accredited school groups has been reached (according to the number of students) visit applications will be rejected.
5. SCHOOL GROUPS WITHOUT ACCREDITATION WILL NOT BE ALLOWED TO ENTER THE SHOW.
6. **The admission cost for each pupil is 10 euro, if pre-accreditation is made by 15 November 2018. After 15th November, upon acceptance, the cost for each student shall be € 15.**
7. Inside the show, the following are strictly forbidden:
  - 7.1. sitting down and lying on the floor;
  - 7.2. asking to take away gelato trays<sup>1</sup>;
  - 7.3. discarding cups, glasses, spoons or refuse of any kind;
  - 7.4. creating disorder or confusion in the halls;
  - 7.5. causing any type of disturbance to exhibitors or visitors.
8. Anyone who fails to comply with one or more of the above rules may be turned out of the show, together with the school group to which he/she belongs. Furthermore, the school to which the offending student belongs will be forbidden from entering the show for 3 subsequent years.
